3 Location and time schedule

- 3.1 **Location:** KLIX airfield
- 3.2 **Registration:** starting November 16, 2025, 9 am
- 3.3 **Confirmation of participation:** until December 31, 2025
- 3.4 **Safety briefing (mandatory):** April 23, 2026, 7 pm
- 3.5 **Weighing of club class and two-seater gliders (mandatory):**
on the training days all day on agreement with the staff and on
April 24, 2026, 8 – 10 am
- 3.6 **Contest flying:** April 24, 2026, to May 2, 2026
- 3.7 **Prize giving and farewell party (changes remain reserved):**
farewell party May 1, 2026, 8 pm
prize giving May 2, 2026, 8 pm
- 3.8 **Unofficial training:** April 22 and April 23, 2026

4 General rules

- 4.1 For the execution of the competition the legal terms and regulations are applying, "Segelflugbetriebsordnung (SBO)" as well as the determinations of the DFS (German air traffic control) and aviation authority of the State of Saxony, sporting code and competition rules of the DAeC (German Aeroclub) in valid versions including changes and amendments, this general rules and local procedures (in the German version), determinations of the competition officials within the opening briefing that are applying for the complete competition and determinations of the competition officials within the daily briefings. Exceptions can be defined by the competition officials. Launch will be possible by aero-towing or self-launching. There will be handicaps used for the scoring in all classes. For that purpose, the DAeC handicap list for competitions from 2025 (for Open-/18m-, standard class), the IGC club class list from October 1, 2024 (for club class), and the IGC 20m Multi-Seat Class list from April 1, 2024 (for double seaters), will be used and hereinafter named handicap list(s) in this document.

- 4.2 There are applying the latest anti-doping rules of the DAeC, which are attached to this document and thus the national anti-doping-code, especially section 9, which says: In individual sports, violation against the anti-doping-rules in connection with an inspection during a competition leads to an annulation of the results achieved in this competition, with all following consequences, including withdrawal of medals, points and prizes. The anti-doping-rules and national antidoping-code, a list of prohibited medicaments, standards for medical permission exceptions are provided on the DAeC homepage, published here (only in German):

This information does not touch the responsibility of all participating pilots to obey the anti-doping rules by themselves.
- 4.3 For flight documentation purposes and as back-up systems, all IGC-approved flight data recorders can be used. FLARM without IGC-approval is valid as a back-up system.
- 4.4 Using FLARM is compulsory for every competition flight.
- 4.5 It is mandatory to carry on board the latest VFR-aeronautical charts that include the reference areas of the ICAO maps Berlin, Nürnberg, Poznan and Wroclaw.
- 4.6 The official competition language is German.
- 4.7 If applicable, regulations regarding the pandemic will be part of the rules document, which will be created following the official regulations.

5 Participants

- 5.1 Every interested pilot with a valid licence can take part.
- 5.2 The organizer remains the right to limit the number of participating aircraft (in total or per class), e.g. due to safety reasons.
- 5.3 A change of the participants in charge is possible. There will be no individual result for the “Deutsche Rangliste Segelflug” (German gliding ranking) or for IGC ranking list for teams consisting out of two or more pilots. (SWO Anlage D „Deutsche Rangliste Segelflug“ Punkt 4.1).

6 Gliders and equipment

- 6.1 Part of the “**Open-/18m class**” are single seater gliders with a wingspan greater than 15m and double seater gliders that are not part of the IGC 20m Multi-Seat Class list. Maximum handicap is 121. Disposable (water) ballast is allowed. Maximal take-off mass is limited to 800 kg. Handicap list in use: „DAeC Indexliste: Wettbewerb 2025 Klassenübergreifend“.
- 6.2 Part of the “**Two-seater class**” are two-seater gliders that are part of the IGC 20m Multi-Seat Class list. Disposable (water) ballast is allowed. Maximal take-off mass is limited to 800 kg. Handicap list in use: IGC 20m Multi-Seat Class List (April 1, 2024).
- 6.3 Part of the “**Standard / 15m class**” are gliders that are listed in „DAeC Indexliste: Wettbewerb 2025 15m Klasse“ or in „DAeC-Indexliste: Wettbewerb 2025 Standardklasse“. Disposable (water) ballast is allowed. Handicap list in use: „DAeC Indexliste: Wettbewerb 2025 Klassenübergreifend“.
- 6.4 Part of the “**Club class**” are gliders according to the IGC Club Class List (October 1, 2024) with their individually adapted handicaps. Disposable (water) ballast must not be used in this class. Handicap list in use: IGC Club Class List (October 1, 2024).
- 6.5 Changes by the competition officials remain reserved.



7 Entry fee and towing fee

7.1 The entry fee is 240,00 € per registered plane. It is a requirement to transfer it in advance, latest December 6, 2025, to the following bank account:

7.2 Pilots that cannot receive a confirmation of participation because of overbooking, will get back their complete payments they have already made.

7.3 If a participant deregisters after receiving the confirmation, for deregistering between January 1, 2026, and March 31, 2026, 50% of the entry fee will be paid back, for deregistering after March 31, 2026 there will be no payback. The host will decide in exceptional cases.

7.4 For one aerotow to 600 m (Club Class: 650 m) a cost of 50,00 € (changes according to fuel price changes remain reserved) will be invoiced for all classes. Self-launchers will pay a handling-fee of 5,00 €. Price raises can be allocated in agreement with the towplane owners.

7.5 Billing of the competition will generally be done with direct debit payment. The corresponding direct debit authorisation needs to be signed before the competition begins, latest in Klix at the registration. The participant must make sure that his bank account allows the debiting. Participants who can't take part in this procedure will pay by cash or card before leaving.

7.6 In case the competition will be cancelled due to regulations connected to the pandemic, the entry fee will be refunded.



8 Accommodation

- 8.1 Klix airfield possesses extensive space as well as modern technical- and sanitary facilities.
- 8.2 There will be the possibility to camp. Including restroom and shower, power supply (which does NOT include the charging of electrical vehicles and electrically powered gliders), waste collection and cleaning we invoice in general for every person 120,00 € and for every child until 12 years 60,00 €.
- 8.3 The charging of electrical vehicles and electrically powered gliders must be coordinated with the competition officials.

9 Service

- 9.1 All results will be presented live on screens in the briefing and communication centre.
- 9.2 From morning until evening warm and cold dishes will be sold. Moreover, the bar “Zur Winde” is inviting for social evenings.
- 9.3 For internet access, Wi-Fi and ethernet-plugs are available. The costs are included in the entry fee.
- 9.4 All the information that are important for the competition and its organization will be communicated via internet and via radio (airfield frequency) to all participants and the helping staff.

10 Registration

Registrations can be done starting **November 16, 2025, 9:00 am**, online only on <http://www.aeroteam.de> As registered counts a pilot in the class in that he/she is registered first. Changes in the class are only possible when there are free capacities. After receiving their registration confirmation, participants of the club class have to hand in the filled weight form (“Gewichtsformblatt Clubklasse” – Anlage G, SWO), the current weight report and the equipment register of their glider until latest March 31, 2026.

11 Liability and legal process

All participants declare with sending the registration that they will renounce all damage compensation claims against the organizer, host and its helping institutions, unless in case of reckless or grossly negligent actions. This waiver does not count as far as an insurer recognizes a claim and settles it. The participants declare for themselves and their teams that they will accept all rules in this document (in the German version). If the participants take place with a glider that is not owned by them, the owner of the glider declares that she/he agrees with the limitation of liability about damage to his/her glider. Minors need the signature of a legal representative. Any recourse to courts of law is excluded.
